EXHIBITION GUIDELINES

1. To participate in this exhibit, you must be a current member of the Grand Marais Art Colony (GMAC).
2. Members are invited to submit up to two pieces of original art. At least one piece must be for sale, but we encourage both pieces be for sale.
3. GMAC encourages artists to submit new artwork and/or artwork not previously shown.
4. All artwork must be ready to exhibit, and;
 - 2D artwork must be wired to hang (no wire exposed above the frame or wrapped canvas)
 - 2D pieces cannot exceed 30" x 30" (in any direction) including frame.
 - 3D artwork must be suitable to be placed on the floor or stand on a table.
 - Literary work must be able to be presented on a pedestal or hung on the wall.
5. Artists receive a 60% commission on artwork sold during the exhibit.
6. Complete the Artwork Submission Form.
 - Make three copies:
Copy 1: Retained by the Art Colony.
Copy 2: Cut and attach to the submitted artwork.
Copy 3: Retain a copy for your records. Forms will also be available at the Art Colony.
 - On 2D work, please attach to the back, lower right corner, on 3D work, attached on the bottom, and tuck a form into literary works.
7. Forms will also be available at the office when you submit your art. **Artwork must be received by GMAC no later than Tuesday, April 21 at NOON to be included in the show.** Artwork can be shipped to the Art Colony: 120 W 3rd Ave, Grand Marais, MN 55604
8. **Unsold artwork must be picked up on Monday, May 4 by 4 pm.**
Artwork can be shipped back to the artist at the artist's expense, please provide packing materials and shipping information if that is desired.
